This Memorandum of Understanding (MoU) is made and entered into on the 16th of June, 2022 to establish cooperation between
Chatia College, PO- Sootea, Biswanath, Assam -784175, represented by Dr. Swapan Kumar Kalita, Principal, Chatia College, Sootea.
and

Biswanath College, Biswanath, Assam- 784189, represented by Dr. Chinta Mani Sharma, Principal, Biswanath College, Biswanath,

Whereas Chatia College and Biswanath College has made this Memorandum of Understanding for collaboration and various mutually benefitting academic activities under the following terms and conditions-

- 1) Students of Chatia College may visit to attend lectures, talks and special classes on relevant topics covering the UG syllabus of Gauhati University at Biswanath College in consultation with the faculty members of Chatia College and vice-versa at mutually agreed upon schedules during the academic session.
- 2) Faculty Members of Chatia College and Biswanath College may take up classes in each other's institutions after prior planning and agreement.
- 3) Both Chatia College and Biswanath College may jointly organize Seminars/ Workshops/Field Trips/Excursions/Surveys etc. in online/ offline mode aided by the

faculty members of both the colleges. Both the colleges may jointly organize "Extension Activities" in adopted schools and villages etc.

- 4) Students and Faculty Members of both the colleges may utilize the available Library & Academic Resources of each other in a mutually benefitting manner.
- 5) The students of Chatia College and Biswanath College will be made to comply with the policies of both the Institutions.

Duration /Term of the MoU:

The MoU shall be valid for 5 (Five) years from the date of its entering into and may be extended from time to time in writing by agreement between the two institutions.

Changes / Amendment

Changes of any kind cannot be made to this MoU without written consent of both the parties. Additions, deletions and alterations to this MoU may be effected with the written agreement of both the parties of this MoU concerning the changes. Documents containing such additions, deletions and alterations and signed by the parties shall form addenda to this MoU and will be deemed part of this MoU.

Statement of Understanding:

- a) This Memorandum of Understanding is a document of good faith and not meant to be legally binding but is intended to provide a platform for promoting harmony between the two institutions in the best interests of the students, faculty members and the communities associated with them.
- b) This agreement will not reduce the full autonomy of either institution, nor may any bindings be imposed by either institution upon the other.


